PROGRAM GOALS

- To help each consumer manage his or her illness(es) in order to prevent psychiatric hospitalization.
- To help each consumer gain the skills necessary to live, learn and work in the community as independently as possible.
- To provide emotional, educative and case management supports in a safe, clean, dignified and therapeutic treatment environment.
- To affirm each consumer's strengths and abilities and to foster a sense of community and social support

Eligibility:

Crossroads accepts individuals who meet the following admission criteria: Be at least 18 years of age; have mental health issues that require a structured day treatment program; be medically stable; be willing to attend the treatment program at least three days per week; and have the ability to pay for services through Medicaid insurance, Magellan Health Services, Independence Blue Cross, AmeriHealth, Horizon Blue Cross and Blue Shield, private pay or other resources.
