Pat has been with Crossroads for the last year as our Advanced Practice Nurse and our primary psychiatric consult. She brings to Crossroads a wealth of knowledge in the medical field and is an expert in her specialty of psychiatry. She offers a rare mix of clinical talent and compassion the clients favor.

Pat grew up in Atlantic County and graduated locally from Holy Spirit High School in Absecon, NJ. She attended Pace College in Westchester, New York and received her degree in Nursing before joining VISTA - Volunteers in Service to America. Pat worked directly with the National Guard to set up a tent city to aid the homeless migrant workers of the Kickapoo & Navaho Indian Nations and legal & illegal Mexican aliens in Utah. In addition, offered emergency medical management and linkage services to several thousand individuals in the migrant community. After that, she spent 20 plus years in California in many areas including ER, ICU, Hospice, Education and Nursing Administration. After completing her Master of Business Administration from St. Mary's College in Moraga, California, Pat returned to Atlantic County and worked as the Director of Nursing at Eastern Pines Nursing Home in Atlantic City, NJ. It was there she had her first clinical exposure with the chronically mentally ill. Since then, Pat has received her Master of Science in Nursing (Adult Psychiatric-Mental Health) from Temple University in Philadelphia, PA and is also Board Certified as an Adult Psychiatric-Mental Health Clinical Nurse Specialist.

Internships Available

Crossroads has internship opportunities available for undergraduates and graduates in the human services field. Both administrative and clinical supervised field placements can be designed for students majoring in psychology, social work, education, criminal justice, etc. In addition, we are interested in exploring a relationship with a student, class or professor interested in research activities.

Partial care is a very good level of care to introduce students to the field of psychiatry, as it is a milieu based program with many opportunities to interact with chronically ill consumers. Depending upon his or her interests and experience, a student may be able to observe and/or participate in any of the following: group therapy; psycho-education groups; therapeutic activities; substance abuse therapies; individual therapy; intake assessments and case management activities. All students would receive individual supervision from a trained clinician and would be encouraged to participate in all staff in-service trainings. As for an administrative internship, we can structure an experience to allow a student to be introduced to many of the non-clinical aspects of operating a health care facility including policy writing, program development, quality improvement activities, human resources issues, billing procedures and how our program fits into the greater mental health continuum of care.

Finally, Crossroads is attempting to develop better outcome measures to demonstrate the impact our services have on our consumers. As this is a complex project, we are open to a partnering with a student and/or research class to help develop and follow through on such measures. This is an ideal opportunity for a student studying statistics, doing research or writing a thesis.

Through our internship program we hope to provide quality learning opportunities to budding human services professionals while strengthening our relationships with local colleges. We anticipate being able to accommodate several students each semester and can be flexible when structuring such experiences.

"For the last 6 months my life was in a downward spiral, finally leaving me homeless. By the grace of god, I reached into my pocket and pulled out a business card with the name of the Crossroads outreach worker and called him. Even though it was after business hours, he answered. He calmed me and said they would have me picked up the next morning. I slept in an emergency room and sure enough, the van came hours later to pick me up. The driver brought me to Crossroads. Once there I was fed, offered shelter, doctors and medical treatment. It truly was a miracle. The staff worked non-stop to help me up when I was at my lowest point."


Male Consumer - Age 47 Mount Holly, Burlington County, NJ
